

## Changes to the MOI

- Our aim was to change the MOI to be more progressive and in line with the future strategy of The Racing Association. We want to modernise the document in line with the current legislation and include the more relevant changes
- We have broadened the transformation objectives to ensure a more holistic transformation of the membership base by including not just a more racially representative membership but one that is more diverse from both a gender and ethnic perspective
- Provision for a new class of non-voting members, this allows the Board to explore new membership initiatives and grow and develop interest in ownership
- Dissolution of Regional Chapters and election of a maximum number of regional members onto the National Board allows for the various regional members to have more appropriate representation and involvement in the overall strategy of the Board.





- RA Vision Change, Restructure and Reinvent
  - Develop the Sport Spectacle and Entertainment
  - Diversity Transform the Reach
  - Grow the Tote and the number of Owners Grow the Return
- Randjesfontein the Property

- The RA Board has invested in a preliminary design and budget assessment for the redevelopment of Randjesfontein into a fully functional racecourse.
- Randjesfontein a country racecourse





- Professional Team includes: An Architect, QS, C&S Engineers, Electrical specialists, Track Design experts and Digital Product specialists. This team is headed by our project development manager Judith Smith
- Design and Development Key Requirements include the following:
  - Get people closer to the horses
  - Synthesize the drama of the Sport of Horseracing with the suburbanite's desire for outdoor living
  - Light footprint Containerised and prefab solutions integrated into a landscaped and pedestrianised multifunctional precinct
  - Digital product is to be integrated into the design





- The provisional racecourse budget including the building costs, track upgrades, development costs and professional fees is approximately R 87 Million
- The timelines on the assumption that the existing design team continue on the project

   is approximately 9 months and this includes the track widening and grass
   establishment, the importation and installation of the running rails and starting stalls,
   general construction, fitout and commissioning.
- The RA does not consider itself to be in the business of property ownership and we have produced this preliminary design concept and budget with the intention of finding an investor in order to bring the vision to life or to buy the property as a whole with the intention of going ahead with the race course development as envisaged in this design. The sale of the property will be conditional and must be in line with the long term objective and protection of horseracing
